The nutritionDay (nDay) Supervisory-Scientific Board (SSB) welcomes all types of research projects linked to data collected on nutritionDay or requiring targeted additional data.

The focus should be primarily the use of the already available data. All submissions and communication has to occur in **English**.

Researchers interested in nDay research, or who are formally involved and actively participate in the nDay audit may submit research projects. This includes all **individual center and unit participants, regional and national coordinators, supporting national and international organizations and members of the nDay board**.



Research Publication

The nutritionDay team will nominate 1- 3 co-authors depending on the involvement of the Vienna Team in the research project. The word "**nutritionDay**" has to appear in the research article **title**.

All the nDay national coordinators, national nutrition societies and participants should be acknowledged in the research paper.

The **source of funding** should be stated as following:

"nutritionDay is yearly financed by ESPEN (the European society for Clinical Nutrition and Metabolism) and by the Medical University of Vienna"

Review process of the research proposal

The nutritionDay SSB reviews the research project and provide written comments to the proposal.

nutritionDay

The investigator will be informed about the SSB feedback within 1 month following the proposal submission. If modifications are requested by the SSB, the investigator will modify and resubmit the proposal

with:

- A point by point reply to all comments of the SSB (like for publications)
- The modified protocol, with relevant changes highlighted in yellow, and the point by point reply (email exchange with nDay office office@nutritionday.org)

The modified protocol is re-sent to the SSB for final approval. The entire process until obtainment of the data might take up to 2 months.

Progress report

Every 6 months after having initiated the nutritionDay project, **the investigator commits to send a short progress report** to the nutritionDay office. It should contain:

- Time line progress
- Results, Quantitative figures if appropriate (% of objectives reached)
- Update on the initial time schedule (possible delays should be explained and a revised time schedule has to be presented (termination, manuscript, publication)
